

In terms of Section 14(1) of the NCTE Act, 1993 ELIM COLLEGE OF EDUCATION. - 3 Now, therefore in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee thereby grants recognition to ELIM COLLEGE OF EDUCATION, EAST GODAVARI DT. ANDHRA PRADESH for B.Ed. Course of One year from the recidence session 2002-2003 with an annual intake of 100 students subject to fulfillment of the following:
 - a) The institution will ensure that 1 faculty members duly approved by the affiliating body are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Committee within one month of commencement of the course.
 - b) The institution shall, within one month of the receipt of order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
 - c) The institution should shift to its own premises within three years from the date of coognition (In case Maycourse is started in rented premises).

- a) The resolution of all comply with the various other norms and standards prescribed in the NCTE Regulations and the institution shall be visited on any day after three months from the date of issue of recognition order for ensuring its satisfactory performance.
- 4 Further, recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- This Order of recognition is subject to the outcome of C.A.No.7756, 7757 & 7758 of 2001 filed before the Hon'ble Supreme Court against order of the Hon'ble Division Bench in W.A.No.. 626/2000 of the Hon'ble High Court of Andhra Pradesh.
- 7 If the institution contravenes any of the above condition or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act.
